SIXTH ANNUAL MEETING - SEPTEMBER 1984

Report of the General Council of NAFO

Tuesday, 11 September - 1015-1045 Friday, 14 September - 1115-1140

- The General Council was called to order at 1015 in the Imperial Ballroom of the Lord Nelson Hotel
 in Halifax on the 11th September 1984 by the Chairperson of the Standing Committee on Finance and
 Administration (STACFAD), Ms Diana Pethick (Canada), who, in the temporary absence of the Chairman,
 Dr V. K. Zilanov (USSR), when the office of Vice-Chairman had been vacated, had been designated by
 unanimous decision to take up the chair of the General Council, in order to proceed to the election
 of a Vice-Chairman.
- 2. The <u>delegate of Canada</u> asked for the floor in order to welcome all participants to Halifax (see Appendix I) and invite them to a reception in the Regency Ballroom of the hotel, that evening, from 1800-2000.
- 3. The Chair proceeded then to the election of a Vice-Chairman, asking for nomination. The delegate of Portugal proposed Mr. H. Schmiegelow (EEC) and his nomination was seconded by Norway. As there was no other nomination and no one was opposed, the Chairperson declared Mr. H. Schmiegelow (EEC) elected Vice-Chairman and requested him to take the chair.
- 4. The Vice-Chairman, acting as Chairman for the remainder of the meeting, took up the appointment of a Rapporteur. Following the traditional procedure, the Executive Secretary was appointed as Rapporteur.
- 5. The Agenda was adopted as proposed (see Appendix II).
- 6. The Chairman then welcomed the observers to the meeting, confirming the credentials of observers from Mexico, Republic of Korea and USA.
- 7. As regards <u>Publicity</u>, the <u>Chairman obtained the approval</u> of the Council for its handling <u>in the</u> usual manner.
- 8. The Proceedings of the 5th Annual Meeting, September 1983 (GC Doc 83/IX/6, Revised) were approved.
- 9. The General Council reviewed its own membership and concluded that it was unchanged. The same was confirmed as to the membership of the Fisheries Commission.
- 10. Coming to item 8 of the Agenda, the <u>Chairman</u> invited the delegate of Canada to explain the purpose of the proposed amendments to the <u>Rules of Procedure</u>.
- 11. The delegate of Canada proposed that, in order to save the time of the Council, a Working Group be formed, under the chairmanship of the Executive Secretary, which would then report to the Council and recommend the action to be taken. This was agreed, and the following delegations, although any Contracting Party would still be free to participate in the work of the Group, immediately confirmed they would appoint delegates to the Group: Canada, Cuba, EEC, Japan, Portugal and USSR. The observer from Mexico declared his interest in the work of the Group and was then permitted to observe its work sessions.
- 12. Coming to item 9 of the Agenda, the delegate of Canada requested that consideration of this item be postponed to a later occasion and this was agreed.
- 13. The Chairman then referred items 10 to 14 and 16 to STACFAD and at 1045 decided to adjourn the meeting.
- 14. The meeting was reconvened at 1115 on 14 September.
 - The Chairman gave the floor to the <u>Chairman of the Working Group on Rules of Procedure</u> and asked for his report.

The Chairman of the Working Group presented his report (GC Doc 84/IX/5) which was approved unanimously. As a result, Contracting Parties agreed to forward to the Executive Secretary, until the end of 1984, their opinion on the text of the proposed new Rules or their proposal of alternate texts, so that a decision would be taken at the next annual meeting.

- 15. Coming to item 9 of the Agenda, <u>Current Threats to Conservation in the Regulatory Area</u>, general consideration was given to what had been presented to the Fisheries Commission regarding non-member countries engaged in fishing in the Regulatory Area, and it was <u>decided</u> that the <u>matter continue</u> in the Agenda for the next year.
- 16. The Chairman invited the discussion of Other Business and the delegate of the EEC profitted from the occasion to inform the Council that Greenland would be leaving the Community by the end of the year and that, in consequence, Denmark had the intent to accede then on behalf of Greenland. In due course this intention and desire would be notified to the Depositary.
- 17. As no other business was proposed for discussion, the Chairman gave the floor to the Chairperson of STACFAD who introduced the Report of that Committee (see Appendix III). The Report was unanimously approved and as a result the Administrative Report of the Executive Secretary was approved as well as the Auditor's Report, and the new form of the General Council's resolution on the Executive Secretary's pension fund. The time and place for future meetings was also thus agreed, with the proviso that the approved budget for 1985 took into consideration the fact that the 1985 annual meeting might still take place outside Canada by invitation of one of the Contracting Parties.
- 18. The Press Statement, drafted in the usual manner, is attached as Appendix IV.
- 19. The Chairman thanked all the delegates and the Secretariat for the work done. Several delegates thanked the Chairman for his work.

The meeting was adjourned at 1140.

Report of the Standing Committee on Finance and Administration (STACFAD)

Monday, 10 September, 1730-1900 Tuesday, 11 September, 1430-1630 Wednesday, 12 September, 1200-1230

- 1. The meeting of STACFAD was called to order by the Chairperson, Ms D. Pethick (Canada).
- 2. The Executive Secretary was appointed as Rapporteur.
- 3. The Agenda, as circulated, was approved. (Annex I)
- 4. The Chair recognized the presence of delegates from Canada, Cuba, Denmark for the Faroe Islands, EEC, the GDR, Japan, Norway, Poland, Portugal, Spain and USSR and an observer from Mexico.
- 5. Under item 4, Review of Membership, it was noted that every Contracting Party, except Bulgaria, Iceland and Romania, were represented in the General Council.
- 6. The Chairperson explained the purpose of the first meeting of STACFAD as a preliminary detailed study of all items on the agenda in anticipation of examination and approval without delay during the week.
- 7. The Auditor's Report was presented and approved.
- 8. Under item 6, Review of costs of the Executive Secretary's pension fund, the Committee considered GC Doc 84/IX/2. After approving the report and conclusions of the Actuaries, STACFAD recommended to the General Council the recommendation of the Actuaries that the pension arrangement for the Executive Secretary be formalized to protect both the employee's expectations and the Organization from legal claim. The terms of the agreement should be prepared by the Actuaries and acceptable to the Executive Secretary. The Executive Secretary should circulate to the General Council members the agreement for their approval. STACFAD also recommended that in the resolution concerning the annual audit of the Executive Secretary's pension fund, due to the downward revision of the amounts originally estimated, the total amount be changed to \$50,000. In addition, that audit should be conducted by the Actuaries retained by the Organization rather than the Organization's Auditors.
- 9. Administrative Report and Financial Statements (NAFO/GC Doc 84/IX/4). STACFAD reviewed the Administrative Report which had been circulated previously to members of the Committee. The question of the amounts still owing by some Contracting Parties was discussed at length. Its relationship with the balance of Accumulated Surplus Account, to be maintained after billing, was pointed out as well as the role and amount reserved for Contingencies. In relation to Statement 5 of the Administrative Report, the delegate of the EEC called the attention of the Committee to the necessity of taking into account the fact that in 1985 Greenland will be withdrawing from the EEC. From the date of withdrawal onwards Denmark intended to accede to the Convention on behalf of Greenland, representing then the Faroe Islands and Greenland. Annex II reflected the foreseeable consequences of these developments on the contribution of Contracting Parties to the 1985 budget. Attention was also drawn to the fact that from then on, in the billing calculations, three (3) (instead of two) coastal states had to be taken into consideration.

In <u>recommending adoption of the Report and the Financial Statements</u> to the General Council, it should be drawn to the attention of the Contracting Parties that the following <u>contributions were still outstanding in 1984:</u>

10. Accumulated Surplus Fund. After consideration of the outstanding debts of contributions from Contracting Parties, in addition to certain items which had been removed or reduced in the proposed 1985 budget, STACFAD agreed to recommend to the General Council that the minimum balance in that fund be raised to \$100,000 from \$75,000.

11. Budget estimate 1985. After a thorough review and amendment of the Preliminary Budget Forecast for 1985, STACFAD agreed to recommend adoption of the budget estimate (Annex III) to the General Council. In doing so, it should be noted that the \$20,000 required for the microfiche project in 1985 would be fully cost recoverable over a two- to three-year period.

In addition, the costs for annual and mid-term meetings were based on meetings being held in Canada. The sum of \$10,000 for Contingencies was removed from the Budget Estimate for 1985 (Annex III) as the increase of \$25,000 in the Accumulated Surplus would cover any possible over-expenditures for the year. Calculations of the contributions from Contracting Parties for 1985 were attached (Annex IV).

- 12. <u>Budget forecast 1986</u> (Annex V) was <u>approved</u>. Revisions similar to those made in the 1985 budget had been applied to the forecast.
- 13. The billing date for 1985. STACFAD had no difficulty with maintaining, as in previous years, February 15, as the billing date for the Organization.
- 14. Time and Place for future meetings.
