NAFO STACTIC Observer Program Review Working Group (WG-OPR) Meeting

23–24 July 2024 Montréal, Québec, Canada

Provisional Agenda

1. Opening by the Chair, Brent Napier (Canada)

The meeting will be opened by the Chair, Brent Napier (Canada).

2. Appointment of Rapporteur

A rapporteur will be nominated and appointed.

3. Adoption of Agenda

4. NAFO CEM Article 30 - 2024 Implementation

At the 2023 Annual Meeting, STACTIC adopted the revisions to the NAFO Observer Scheme in COM Doc. 23-23. The WG-OPR will discuss the implementation of the 2024 measures to date, and report to STACTIC to facilitate their review on the implementation of the newly endorsed observer program. Specific items that STACTIC has requested the WG-OPR to review include:

a. Observer coverage levels

In accordance with task 1 of the WG-OPR terms of reference (<u>COM Doc. 23-25</u>), discussions on the minimum level of observer coverage required under derogation.

b. Observer application

The NAFO Secretariat will provide an update on the status of the observer reporting application. The working group, in accordance with task 2 of the WG-OPR terms of reference (<u>COM Doc. 23-25</u>) will also discuss the use of the observer electronic application and its implementation.

c. Electric observation program

In accordance with task 3 of the WG-OPR terms of reference (<u>COM Doc. 23-25</u>), and as agreed at the 2023 Annual Meeting, the working group will discuss and draft minimum standards and criteria needed to implement the use of an electronic observer program, and how those systems will be used as an alternative to Observers.

d. Data collection - Garbage disposal

In accordance with task 4 of the WG-OPR terms of reference (<u>COM Doc. 23-25</u>), and as agreed at the 2023 Annual Meeting and 2024 STACTIC Intersessional Meeting, the WG-OPR will discuss observer data collection on garbage disposal and the possible inclusion collection of vessel's garbage disposal practices in the observer reporting requirements.

e. Data collection - Sharks

In accordance with task 5 of the WG-OPR terms of reference (<u>COM Doc. 23-25</u>), the WG-OPR will discuss potential improvements on the data collection of sharks. Part of this work includes reviewing the findings presented in STACTIC WP 21-49 Rev3 "Review of Greenland shark Data Collection and Methodologies" and pursuing the development of standardized handling as well as the development for a species identification guide / observer handbook for sharks.

f. Review of infringements

In accordance with task 6 of the WG-OPR terms of reference (<u>COM Doc. 23-25</u>), the WG-OPR will consider revisions of infringements relating to the Observer Program.

g. Data collection - Quality control

In accordance with task 7 of the WG-OPR terms of reference (<u>COM Doc. 23-25</u>), the WG-OPR will discuss mechanisms to promote quality control for Observer and electronic observation data.

5. Data collection - Data confidentiality

At the 2024 STACTIC Intersessional meeting, it was agreed that the WG-OPR should consider a review of the provisions on the data confidentiality measures in the NAFO CEM.

6. Reporting template

At the 2023 Annual Meeting, STACTIC adopted a reporting template outlined in STACTIC WP 23-20, and it was agreed t the 2024 STACTIC Intersessional meeting that the WG-OPR would review this template.
